Know all by these presents, that the undersigned hereby makes, constitutes and appoints each of Madeline Finney, Mark Davidson, Brandon Gall, Kathleen Molamphy, and Zoe Vantzios, with full power of substitution and re-substitution, acting individually, as the undersigned's true and lawful attorney-in-fact (each of such persons and their substitutes hereafter referred to as an "*Attorney-in-Fact*"), with full power and authority as hereinafter described on behalf of and in the undersigned's name, place and stead, in any and all capacities to:
